We expanded an open source community that fosters transparency and data-driven results in the tree planting sector. We also reached our set goal of target users and numbers of trees monitored within the beta test phase and continued with our pilot projects in Tanzania transforming small scale mono-cropped fields into Agroforestry while running functional tests on GreenStand's tree tracker.
